#### REACH – Candidate List of Substances of Very High Concern

Date. 26 February 2024

On January 23, 2024, the European Chemicals Agency (ECHA) updated the Candidate List of Substances of Very High Concern (SVHC). Under the REACH Regulation No 1907/2006 Article 33, Avery Dennison Materials Group Europe are required to inform our customers about any products exceeding the 0.1% w/w threshold for SVHC content.

Avery Dennison Materials Group Europe, as a downstream user of chemical substances, actively works with our suppliers to ensure adherence to REACH regulations. This effort includes the continuous monitoring of substance registration from suppliers, and products containing SVHC.

Per ECHA's Guidelines on substances in articles, specified in Appendix 3/ Table 6, our self-adhesive products are recognized as articles containing an integrated substance or mixture, and considered as articles under the REACH definition. Specifically, a self-adhesive laminate is categorized into two distinct articles:

- Face material and adhesive (one article)
- Liner and silicone coating (one article)

Below, you will find an updated inventory of products containing SVHC that Avery Dennison Materials Group Europe has been offering since January 2024.

Products marked with \* previously met the SVHC reporting criteria before January 2024. Starting January 2024, these products no longer meet the reporting criteria.
